Public contract:	100Hz, 100mJ-class Amplifier Pursuant to Section 14 of the Act the Public Contract is a below threshold public contract for supplies. Pursuant to Section 53 of the Act the Contracting authority carries out the Procurement Procedure as a simplified below-threshold procedure.

(b) Subject-matter of the Public Contract:

The subject-matter of this Public contract is delivery of 100Hz, 100mJ-class Amplifier. The supply of this amplifier (whole system including ancillary equipment) is requested to form an integral part of the front end for a 10 J laser system being built at Science and Technology Facilities Council (STFC) site at Rutherford Appleton Laboratory (RAL) in the UK. The System will be placed, tested and operated at Rutherford Appleton Laboratory (RAL) in the UK before being commissioned at the HiLASE facility in the Czech Republic.

Subject-matter of the Public Contract is in detail specified in Annex No. 1 Technical Specification and Annex No. 2 Purchase Contract hereto.

(c) The price agreed in the Public Contract:

The contract was not concluded.

(f) The identification of all participants excluded from the Procurement Procedure including a statement of grounds for its exclusion:

The Contracting Authority excluded from the procurement procedure the participant **Lastronics Jena GmbH**, Moritz-von-Rohr-Straße 9, 07745 Jena, Germany, Company ID No.: Amtsgericht Jena HRB 504004, ID 19604077, because of following reasons.

The Contracting authority has concluded that the bid of the participant failure to meet the following award criterion set in Article 2.3 of Procurement documentation:

Maximum permissible total bid price is <u>180.000 EUR</u> (in words: one hundred eighty thousand euros) without VAT and without appropriate customs duties. The bid price must also include any and all costs even those not explicitly specified but about which the economic operator knew or should and could have known considering its professional knowledge, exercising all professional care.

The maximum permissible total bid price cannot be exceeded by the participant in their bids. Should the participant's total bid price exceed the referred-to maximum value, then the participant shall be excluded for the reason of its failure to meet the award criteria.

In accordance with Section 37 of the Act, the maximum permissible total bid price is an objective condition for the economic operator's participation in the Procurement procedure and, in accordance with Section 103 (1) (a) of the Act, an <u>obligatory data for the purposes of</u> evaluating the bids.

The total bid price was one of the criteria for evaluating bids. Pursuant to the Section 46 (2) of the Act after the expiry of the time limit for the submission of tenders, the tender cannot be altered in the data to be subject of the evaluation of tenders. Because of that the Contracting Authority could not apply the Section § 46 of the Act and allow the Participant to explain or supplement this data (total bid price) in the bid.

The Participant's total bid price is <u>206.000 EUR net of VAT</u>. Because the maximum permissible total bid price was exceeded by the Participant in its bid, the Contracting Authority was obliged to exclude the participant for the reason of its failure to meet the award criteria.
