### 1. SPECIFICATION OF SUBJECT MATTER OF PUBLIC CONTRACT

#### 1.1. CLASSIFICATION OF THE SUBJECT MATTER

#### 1.2. DESCRIPTION OF SUBJECT MATTER OF PUBLIC CONTRACT

The Contracting Authority, whose main activity is to conduct research and development in the physical sciences, is the recipient of the grant for the project "ELI: Extreme Light Infrastructure – Phase 2" implemented under the Operational Programme Research, Development and Education (hereinafter the "Project").



The subject matter of this public contract is a delivery of a X-ray Diffraction Station with qualities and technical parameters described in the RSD (hereafter the "Device") which forms Annex No. 4 hereto.

The following activities form an integral part of the performance to be provided by the applicant:

- a) design of the Device approved by the Contracting Authority,
- b) packing and transportation of the Device to the place of performance, unpacking and checking in the extent specified in the RSD,
- c) preparation of and the handover of the instructions and manuals and other documents in the extent specified in the RSD,
- d) installation of the Device in the place of installation defined below, verification that the Device is fully functional and that fulfils all requirements stipulated in the Contract, testing of the Device and demonstrating its functionality in the extent specified in the RSD,
- e) training of the persons designated by the Contracting Authority in the extent specified in the Technical Specification.

(The Device and the activities required under para 2 above are hereinafter referred to as the "Delivery").

The applicant shall be obliged to prepare the bid in accordance with all requirements of the Contracting Authority and in accordance with this tender documentation and all its Annexes.

### 1.3. PUBLIC CONTRACT PERFORMANCE TERM

### 1.5. EXPECTED VALUE OF THE PUBLIC CONTRACT

330 000 EUR net of VAT

The expected value of the contract in each part is also the maximum value of the public contract in the appropriate part, which cannot be exceeded by the bidders. Should the bidder's bid price exceed the referred-to maximum value, then the bid shall be excluded for the reason of failing to meet the tender conditions.



The Subject Matter shall be funded from the Research, Development and Education Operational Programme

## **2. BID PROCESSING CONDITIONS AND REQUIREMENTS**

### **2.1. TERM OF BID SUBMISSION**

Bids shall be submitted not later than **10. 1. 2017 at 2:00 PM.**

### **2.2. SUBMISSION REQUIREMENTS**

The Contracting Authority will only accept bids submitted in hardcopy format. The Contracting Authority does not permit the electronic submission of bids.

### **2.3. HARDCOPY SUBMISSION OF BIDS**

Bids in hardcopy format are submitted in a properly sealed envelope, which must be clearly marked with the name of the public contract to which the applicant is submitting the bid, i.e. "Do not open: **Public Contract – X-ray Diffraction Station**".

The Contracting Authority recommends that the envelope must indicate an address to which a notice on late submission of the bid may be sent.

Hardcopy bids are submitted by the aforementioned deadline for submitting bids to the address: **OTIDEA avz s.r.o., Building METEOR C (3<sup>rd</sup> floor), Thámova 681/32, 180 00 Prague 8 - Karlín.**

Bids may be delivered in any appropriate manner (by post, courier service, in person, etc.) at the address above on working days from 8:30 AM to 3:30 PM; by **2:00 PM** only on the final day of the term. Any other delivery shall not be deemed proper submission of a bid.

### **2.4. IDENTIFICATION DATA**

The bid must include identification details of the applicant, in particular the following: commercial name of the company, registered office, ID No., person authorised to act on behalf of the applicant or a person authorised to represent the applicant, contact address for correspondence between the applicant and the Contracting Authority.

### **2.5. REQUIRED LANGUAGE**

The bid must be written in Czech or English and contain a draft contract signed by the person authorised to act on behalf of or in the capacity of the applicant. Documents on qualification may be submitted in Czech or English. Documents on Basic and Professional criteria may be submitted in German as well).

### **2.6. FORMAL RECOMMENDATIONS**

All bid sheets shall be numbered in an ascending continuous series and put firmly together or stitched so that they are adequately secured against falling out of the bid. The bids shall be properly readable with no cancellation and overwriting. The Contracting Authority recommends submitting the bid in an electronic form on a CD, either in an MS Office or a compatible or .pdf format as well.



## 2.7. COPIES

The applicant shall submit the bid in an original copy. In addition to this original copy, the Contracting Authority also recommends submitting a copy of the applicant's bid.

## 2.8. JOINT BID

If the bid is submitted jointly by more applicants (joint bid), the applicant shall specify a person in the bid who shall be empowered to represent these applicants for communicating with the Contracting Authority during the tender procedure.

## 2.9. BID STRUCTURE

The applicant shall submit the bid containing the following documents and parts, whereas the following structure is only recommended:

### 1. Bid cover note

The bid cover note shall include the following details: Public Contract name, including the name of part of the public contract, basic identification details of the Contracting Authority and applicant (including persons empowered to be involved in further proceedings), bid price structured according to this tender documentation and other data relevant for purposes of evaluation, date and signature of the person authorised to act on behalf of the applicant. The applicant may use **Annex No. 1** hereto.

### 2. Table of contents

It must include all sections of the bid mentioned herein, structured as required, to which numbers of appropriate sheets or pages shall be assigned.

### 3. General information on the applicant

Name of the applicant, legal form, registered office, Company identification No., Tax identification No., bank, names of company statutory body members incl. contact details (phone, fax, e-mail, address), person authorised to be involved in further proceedings including written authorisation to represent and company profile. Bidder shall state the **contact e-mail address** for electronic communication with the Contracting Authority. The address will be used for the service of the Contracting Authority's electronically signed documents concerning the assessment and evaluation of the bids during this tender procedure.

### 4. Documents demonstrating qualification meeting structured as mentioned in Article 3 hereof.

### 5. Bid price structured as required under Article 5 of this tender documentation.

### 6. Binding contract signed by a person authorised to act on behalf of or in the capacity of the applicant where the applicant shall be obliged to use the appropriate draft contract wording mentioned in **Annex No. 5** hereto and to complete only those parts, which are explicitly specified by the Contracting Authority to be filled by the applicant with a yellow colour.

## 2.10. REQUEST TO EXPLAIN THE TENDER DOCUMENTATION

The Contracting Authority will provide explanations to the tender documentation based on a request pursuant to Section 98 of the Act. ## 2.11. DOCUMENTS SUBMISSION BY FOREIGN CONTRACTORS

In case that the Act or the Contracting Authority requires to submit a document in compliance to the law of the Czech Republic, applicant is entitled to submit a similar document issued pursuant to the legal code of the country where the document has been issued. The document shall be submitted Czech language or any other language allowed by the Contracting Authority in this tender documentation.

The document can be substituted by affidavit in the case that the document is not being issued pursuant to the legal code of the country of contractor's registered office.

## 3. QUALIFICATION OF APPLICANTS

### 3.1. QUALIFICATION

A contractor qualifies for performance of the public contract if they prove fulfilment:

1. Basic Criteria
2. Professional Criteria
3. Technical Qualification Criteria

#### 3.1.1. BASIC CRITERIA

A contractor is not qualified if:

- a) it was effectively convicted of a criminal offence listed in Annex No. 3 to the Act or for a similar offence pursuant to the legal code of the country of contractor's registered office in the country of its registered office in the last 5 years before commencement of the tender; expunged convictions are not taken into account,
- b) it has a due tax arrears in the tax records in the Czech Republic or the country of its registered office,
- c) it has due arrears on premiums or penalties on public health insurance in the Czech Republic or the country of its registered office,
- d) it has due arrears on premiums or penalties on social security and contributions to the state employment policy in the Czech Republic or the country of its registered office,
- e) if is in liquidation, if a decision on default has been issued against it, if it has been ordered to go into forced receivership pursuant to other legal regulations, or is in a similar situation pursuant to the legal code of the country of the contractor's registered office.

The contractor proves the fulfilment of the basic qualification criteria in relation to the Czech Republic by submitting:

- a) Extract from the Criminal Records for point 3.1.1(a) of the tender documentation, if the contractor is a corporate entity, this condition must be fulfilled by the corporate entity and also by every member of the statutory body. If the member of the contractor's statutory body is a corporate entity, this condition must be fulfilled by this corporate entity and the person representing this corporate entity in the contractor's statutory body.
- a) Confirmation from the relevant financial bureau in relation to point 3.1.1(b) of the tender documentation,



- b) Written affidavit in relation to excise tax pursuant to point 3.1.1(b) of the tender documentation,
- c) Written affidavit in relation to public health insurance pursuant to point 3.3.1(c) of the tender documentation,
- d) Confirmation from the relevant district social security administration in relation to point 3.3.1(d) of the tender documentation,
- e) Extract from the commercial register or submission of an affidavit if it is not registered in the commercial register.

### **3.1.2. PROFESSIONAL CRITERIA**

The professional criteria will be proven by an applicant who submits:

- Pursuant to Section 77(1) of the Act, in relation to the Czech Republic, an extract from the commercial register or other similar records, if other legal regulations require registration in such records.

### **3.1.3. TECHNICAL QUALIFICATION CRITERIA**

The technical qualification criteria will be proven by a applicant who submits:

- Pursuant to Section 79(2)(b) of the Act a list of important supplies provided in the past 3 years before commencement of the tender, including indication of the price and period of provision and identification of the client.

#### Minimal level of qualification and manner of fulfilment proving:

An important supply shall consist of a delivery of at least 2 systems similar to the subject matter of this tender and each of delivery in a minimal financial extent of 150 000 EUR.

Applicant shall make a part of its bid an affidavit on due provision of previous similar supply that shall contain at least the following information (1) name of the client and its registered seat, (2) description of supplies provided, (3) year of their provision and (4) name of contact person along contact information, where the Contracting Authority may verify the provided information.

Applicants are recommended to use a form affidavit that is attached hereto as an Annex No 3.

## **3.2. FORMAL REQUIREMENTS OF QUALIFICATION DOCUMENTS**

The contractor will submit simple copies of documents proving the fulfilment of qualification criteria. Before concluding the contract, the Contracting Authority will always request that the selected contractor submit the originals or officially certified copies of the qualification documents, unless these were already submitted in the tender.

Documents proving the fulfilment of qualification criteria which are in a language other than the Czech, Slovak or any other language allowed in this tender documentation language must be translated into the Czech language or any other language allowed in this tender documentation. Documents proving the basic qualification criteria pursuant to Section 74 of the Act and professional qualification criteria pursuant to Section 77(1) of the Act must prove the fulfilment



of the required qualification criterion no more than 3 months before the commencement date of the tender.

### **3.3. DOCUMENTS ON QUALIFICATION SUBSTITUTION BY MEANS OF AFFIDAVIT**

The Contracting Authority stipulates pursuant to Section 86(3) of the Act that applicant is entitled to substitute the aforementioned documents required within **basic** and **professional** criteria by means of affidavit. Applicants are recommended to use a form affidavit that is attached hereto as an **Annex No 2**.

The Contracting Authority requires applicant to submit in bid particular aforementioned list of important supplies within **technical** qualification criterion. Applicants are recommended to use a form affidavit that is attached hereto as an **Annex No 3**.

### **3.4. PROOF OF QUALIFICATIONS ACQUIRED ABROAD**

In case that qualification has been acquired abroad, applicant shall prove such qualification with documents issued pursuant to the legal code of the country where the document has been issued and in the extent required by the Contracting Authority.

### **3.5. PROVING QUALIFICATION THROUGH A SUBCONTRACTOR**

The contractor may prove a certain part of its economic qualification criteria, technical qualification criteria or professional qualification criteria, with the exception of the criteria pursuant to Section 77(1) of the Act, required by the Contracting Authority, through third parties. In this case, the contractor is obliged to submit to the Contracting Authority:

1. documents proving the fulfilment of professional qualification criteria pursuant to Section 77(1) of the Act by the third party,
2. documents proving the fulfilment of the missing part of the qualification criteria by the third party,
3. document proving the fulfilment of basic qualification criteria pursuant to Section 74 of the Act by another party, and
4. written commitment of the other party to provide the fulfilment intended to perform the public contract or to provide the assets or rights which the contractor will use in order to perform the public contract, minimally in the scope in which this other party proved the qualification criteria on behalf of the contractor.

### **3.6. JOINT BID**

In the event of collective participation of applicants, the basic qualification criteria and professional qualification criteria pursuant to Section 77(1) of the Act must be proven individually by each contractor.

## **4. TECHNICAL CONDITIONS**

### **4.1. TECHNICAL CONDITIONS SPECIFICATION**



The Subject Matter (the offered technical solution) of the Public Contract must meet all requirements specified in this Tender Documentation and all its Annexes.

## 5. MANNER OF PROCESSING THE PRICE BID

### 5.1. BID PRICE BREAKDOWN

The applicant shall be obliged to give the total bid price in the following structure: price in EUR net of VAT and total bid price in EUR including VAT (*stating a bid price in EUR including VAT is not applicable for foreign bidders*). The same amount shall be stated in the Cover Bid Note.

### 5.2. BID PRICE SCOPE

The bid price shall be a fixed and binding maximum permissible price including all fees and any other costs connected with performing the Public Contract. The bid price must also include any costs not explicitly specified but about which the bidder knew or should and could have known considering its professional knowledge, exercising all professional care.

### 5.3. BID PRICE MODIFICATION

The price may only be modified in connection with any changes to tax regulations regarding the VAT.

### 5.4. BID PRICE LIMITATION

If the bid price exceeds the maximum allowed price, the applicant shall be excluded from the tender procedure by the Contracting Authority (see art. 1.4 above).

## 6. PAYMENT CONDITIONS

### 6.1. PAYMENT CONDITIONS SPECIFICATION

Payment conditions are specified in the binding draft contract that is an integral part of this tender documentation in a form of Annex No. 5.

## 7. EVALUATION CRITERIA

Bids shall be evaluated pursuant to Section 114(1) of the Act based on economic merit of the bids.

### 7.1. EVALUATION CRITERIA SPECIFICATION

Bid evaluation will take into consideration the evaluation criteria and their respective weights, using a point system on a scale from 1 to 100 points.

Each of the bids shall be awarded a point score, according to individual evaluation criteria, reflecting its success within that criterion.

The Contracting Authority has stated the following evaluation criteria of economic merit of bids:

#### 1. Bid Price

The Contracting Authority evaluates the total bid price in EUR net of VAT. The price shall be given in the structure defined in the Article 5 hereto.

The cost evaluation parameter is calculated in accordance with the ratio between the lowest proposed bid and the evaluated bid in question. Weight of this partial criterion is 70 % and a maximum of possibly gained number of points is 70 within this criterion. The Contracting Authority compares values of this partial criteria offered by each applicant with the value of applicant who offered the most suitable value among all bids within this partial criterion.

Within this partial criterion the points shall be awarded accordingly:

$$\text{Number of points (Bid Price)} = \left( \frac{\text{Bid Price of Most Suitable Bid}}{\text{Bid Price Evaluated Bid}} \times 70 \right)$$

The most suitable bid within this evaluation criterion is the one with the lowest bid price.

#### 2. Warranty length

The Contracting Authority evaluates the length of provided warranty. Bidder shall state the length of provided warranty in whole calendar months.

Weight of this partial criterion is 15% and a maximum of possibly gained number of points is 15. The Contracting Authority compares values of this partial criteria offered by each applicant with the value of applicant who offered the most suitable value among all bids within this partial criterion.

For this evaluation the warranties are divided into three different parts. The warranty for each part must be greater or equal to the requested minimum (24 months). The parts that are evaluated are:

- **Diffractionmeter (consisting of the two circle goniometer with motorized linear detector stage, the open Eulerian cradle and the Single crystal head unit)**
- **Source and X-ray optics**
- **Other components**

The maximum length of warranty for purposes of evaluation for each part is 60 months. Should the applicant's length of provided warranty be stated outside this obligatory scope, i.e. longer than 60 months for a part, then for purposes of evaluation and points awarding number of 60 months for the part shall be used.

Points for the evaluation shall be calculated according to the formula:

**Warranty months = Total Length of Provided Warranty on Diffractionmeter + Total Length of Provided Warranty on Source and X-ray optics + Total Length of Provided Warranty on other components.**



$$\text{Number of points (Warranty Length)} = \left( \frac{\text{Warranty months of Evaluated Bid}}{\text{Warranty months of Most Suitable Bid}} \times 15 \right)$$

The most suitable bid within this evaluation criterion is the bid that accumulates the most warranty months.

### 3. Suitability and Quality Performance Evaluation

The Contracting Authority evaluates suitability and quality performance of the provided subject matter.

Weight of this partial criterion is 15% and a maximum of possibly gained number of points is 15. The breakdown of the points awarded for the technical performance is as follows:

Should the applicant's technical solution's aforementioned parameters be stated outside the obligatory scope (requested minimum), then the applicant shall be excluded for the reason of failing to meet the tender conditions.



In case of gaining 0 point for technical solution's aforementioned parameters, it does not mean failure to meet the tender conditions.

The contracting authority evaluates the total point amount. The total point amount is calculated as a sum of points gained from each section of Suitability and Quality Performance Evaluation, see the chart above. Final result is calculated as amount of gained points:

$$\begin{aligned} &\text{Number of points (Suitability and Quality Performance Criterion)} \\ &= \text{amount of points gained} \end{aligned}$$

Applicant is obliged to state the above required parameters and offered values of his technical solution within the Cover Bid Note.

The applicant shall not be authorised to make the bid subject to any conditions. Any conditions or provision of several different values in the bid in parts that are subject to the evaluation shall constitute a reason to exclude the applicant from the tender procedure.

In case of equality of the gained total point evaluation, the number of points within the evaluation criteria, alternatively partial evaluation criteria will be decisive in this order: Warranty Length, Allowed weight load of the Open Eulerian Cradle, Position accuracy of the 2-Circle Goniometer and Position accuracy of the Open Eulerian Cradle.

## **8. OTHER REQUIREMENTS**

### **8.1. VERIFICATION OF INFORMATION**

In accordance with Section 39(5) of the Act, the Contracting Authority may verify the authenticity of data, documents, samples or models provided by the applicant and may also procure them itself.

### **8.2. COOPERATION BEFORE SIGNING THE AGREEMENT**

The Contracting Authority requires pursuant to Section 104(2) of the Act additional conditions from the selected contractor in order to conclude the agreement:

- a) identification data of all persons, who are the actual owners of the selected contractor pursuant to the Act No. 253/2008 Coll., and
- b) documents from which it arises the mutual relationship between all the actual owners and the applicant, in particular:
  - extract from the commercial register or other similar records,
  - list of shareholders,
  - the decision of the statutory body for the payment of profit sharing,
  - memorandum of association or articles of association
