The subject-matter of performance is complete supply of CONTINUOUS LINE FOR TUBE PLATING (Zn+AL alloy) AND PLASTIC COATING.

The supply is described in detail in an appendix to the TD - Technical Specification. Contracting authority does not submit to subcontract these components of the line: flying saw, decoiler, straightener, sorting table and PLC control of the whole line.

If the tender documents or appendices thereof contain particular commercial names, they only delimitate the required standard and the contracting authority allows for a different, comparable technical and quality solution.

3) Time and place of contract performance

Contracting authority's plant at the contracting authority's address. The time of performance is stipulated in the Draft Business Terms and Conditions.

4) Demonstration of qualification requirements

A supplier shall be considered qualified for fulfilling the contract if the supplier

- a) meets the basic qualification requirements pursuant to Section 53 of the Act
 - meeting of the qualification requirement is documented by submitting of a filled in and signed tenderer's Affirmation forming Appendix No. 2 to the Tender Documents hereof
- b) meets the professional qualification requirements pursuant to Section 54 of the Act
 - meeting of the qualification requirement for Section 54(a) is documented by a copy of entry in the Commercial Register if the tenderer is registered therein or a copy of entry in a similar register if the tenderer is registered therein. Method of substantiation: plain copy of informative copy of entry not older than 90 days as of the day the tender is submitted. ¹
 - meeting of the qualification requirement for Section 54(b) of the Act is documented by submitting of a filled in and signed tenderer's Affirmation forming Appendix No. 2 to the Tender Documents hereof
- c) meets the technical qualification requirements pursuant to Section 56 of the Act.
 - The scope of the required information and documents according to section 56(5)(a) of the Act:

In order to document meeting of technical qualification requirements the supplier shall submit a list of contracts implemented in past 5 years.

- The manner of demonstrating compliance with the qualification requirements pursuant to Section 56(5)(b) of the Act:

Submitting of a signed list of major contracts which shall show meeting of the level of the qualification requirement specified below. The list must include client's identification details, description of performance, price, time and place of performance and client's contact details. The list shall be signed by the person authorized to act on behalf of the tenderer.²

- Definition of the minimum level of qualification requirement corresponding to the type, scope and complexity of the subject-matter of the public contract according to Section 56(5)(c) of the Act:

Contractor meets the technical qualification requirement if he demonstrates experience at

a) the delivery portion of continuous lines for plating and coating for the brake tubes in automotive - min. 3 lines for the last 5 years and at the same time

b) delivery of flying saw for brake or fuel lines for the automotive industry
- min. 5 flying saws for the last 5 years and at the same time

c) supplying "coiler and decoiler" for brake or fuel lines in automotive
- min. 5 coilers and 5 decoilers for the last 5 years and at the same time

d) supplying of crimping and straightening equipments for producing brake or fuel tubes in automotive - min. 3 machines for the last 5 years

d) it is economically and financially qualified to perform the contract

- meeting of the qualification requirement is documented by submitting of a filled in and signed tenderer's Affirmation forming Appendix No. 2 to the Tender Documents hereof

5) Tender processing conditions and requirements

- a) The tender shall be submitted as 1 original document. The contracting authority further requests submitting of the tender as 1 PDF format copy on a CD (full tender including signatures).
- b) The tender shall be written in the Czech or English language. Submitting of other technical documents including language requirements is regulated in Appendix No. 4 to the CD hereof.

- c) The tender shall not include any overwritten text or corrections that could mislead the contracting authority. The contracting authority recommends the tender be secured against tampering with individual sheets.
- d) Content of the tender
 - a. Tender cover sheet
 - b. Proof of the tenderer's qualification
 - c. Signed draft contract for work, completed in yellow marked areas and signed by the legal representative of the applicant
 - d. Technical specification of the offered performance – the tenderer shall include a detailed description of the offered equipment (e.g. product sheet) which shall show meeting of all the requirements stated by technical specifications attached to the Tender Documents
 - e. Other data included in the tender (delivery date, guarantee period, tender validity, guarantee service specification – must be in conformity with Appendix No. 3 of the TD - Draft business conditions_copper coating)

6) Tender price processing method

A tenderer shall specify its tender price for performance of the whole subject-matter of performance. The tender price shall be produced and created in line with the Tender Documents and itemized as follows:

- By items of separate sections of the complete line including names of subcontractors and purchased components
- Electronics and software for the complete line
- Installation of the complete line
- Transportation
- Trial run – expected time and material requirement

The tender price shall be **»the highest admissible price«**.

The tender price shall be stated in CZK and broken down as follows: tender price excl. VAT (Value Added Tax), VAT separately (VAT rate according to effective legislation), and tender price incl. VAT.

The total tender price structured as specified above shall be shown on the tender cover page. All costs and expenditures incurred due to preparation and submitting of a tender shall be borne by the tenderer.

The price shall include all costs necessary for proper, complete and quality fulfillment of the subject of the contract, including all risks and influences related to fulfillment of the subject

of the contract. The tender price must further include insurance, guarantees, taxes, customs, fees, inflation effects and any other expenses required for the contract to be implemented.

The contracting authority does not admit exceeding of the tender price excluding statutory changes of VAT rates.

7) Basic evaluation criterion and evaluation methods

The basic criterion for awarding the contract is the economic advantageousness of a tender.

The evaluation sub-criteria are as follows:

evaluation sub-criterion	criterion weight in %
Tender price	100 %

A tenderer shall quote its tender price in CZK in the cover page and in the draft contract for work.

The contracting authority shall determine the standings according to the success of individual tenders, whereas the points shall be calculated using the formula below

$100 * (\text{most competitive tender} / \text{tender being assessed}) * \text{weight expressed as a decimal number}$

10) Business terms and conditions

This draft contract for work shall be binding for the tenderer and the tenderer shall fill the document only at places where it follows from the text of the draft contract for work (parts highlighted in yellow). In the case of discrepancy between the data contained in individual parts of the Tender Documents hereof, the data contained in this contract for work shall be decisive for preparation of a tender.

11) Tender option requirements

The contracting authority does not allow any tender options.

12) Provision of additional information and inspection of the place of performance

Tenderers shall be entitled to request additional information to tender conditions. The contracting authority must receive the written request at least 6 business days before the tender submission deadline. The contracting authority shall send the requested additional information on the terms of reference no more than 4 business days after the delivery a request. The contracting authority may also provide the tenderers with additional information about the tender conditions without any prior request.
