Type of public contract and type of procurement procedure

It was a public supply contract.

Public contract was contracted within the simplified below-threshold procedure pursuant to Section 53 of the Act.

Definition of the subject matter of the Public contract

Description of the subject matter of the Public Contract

The subject matter of this Public Contract was supply (acquisition) of a reliable and high-performance Deep Ultraviolet laser system for inscription of fiber Bragg gratings. The subject matter of this Public Contract was the supply (acquisition) of a single transverse and longitudinal mode diode-pumped solid-state Deep Ultraviolet pulse laser. The laser must operate at a wavelength within the range of 212 nm to 214 nm (hereinafter referred to as the „**supply**“), and shall be delivered under the DDP (Delivered Duty Paid) clause in accordance with INCOTERMS 2020 terms.

All equipment must be fully operational and complete. More detailed specification of the subject matter was provided in Article 4 of the tender documentation.

The supply included installation and commissioning of the device and training of its operators. The subject of the supply was the delivery of a new and unused instrument from official distribution, intended for use in the Czech Republic, including all documents (in particular the warranty certificate and printed or electronic instructions for use in the Czech or English language).

The Public Contract was co-financed by the European Regional Development Fund and the European Social Fund Plus under the Operational Programme Jan Amos Komenský (OP JAK), reg. no. CZ.02.01.01/00/22_008/0004573 – LasApp.
