Regarding the booth construction for Czech pavilion at CIGF 2016 which will be held on 9-12 June 2016 in Ningbo, In order to protect the benefits of both parties, and accordance with P.R. China's Contract Law, the entrusting party and the entrusted party have reached an agreement as follow:

1. Party B provides Party A booth design & constructing service, according to Party A's request

Exhibition: CIGF 2016

Date: 9-12 June 2016

Venue: Ningbo

Booth: 240sqm

For: Booth Construction

2. Party B will enter the hall on 6 June, 2016, according to the schedule of exhibition organizer, to install the booth according to the designed drawings, finish the installation before 18:00 PM of 8 June 2016,

Booth handover on 8.06. after 18:00 – 5% deduction fine of the contract amount

Booth handover on 8.06. after 20:00 – 10% deduction fine of the contract amount

Booth handover on 9.06. after 08:00 – 15% deduction fine of the contract amount and start to dismantle at 16:00 of 12 June. 2016.



3. The full contract value is CNY14,9495.00 which includes all main items listed on quotation, but not include electricity fee, hall fee, or anything item not mentioned in quotation.
4. Terms of payment: 65% deposit (CNY97,171.75), must be paid before the show; and the 35% balance (CNY52,323.25) must be paid within two weeks the show ends.
5. The bank of Party B is as follow:

6. Party B will be liable for and indemnify Party A the loss or damage caused by Party B for he doesn't finish the booth construction on time or postpone the construction period; Party B will also be liable for and indemnify the safety of the booth. Party B will compensate Party A for safety problems,
7. Party B will clean the booth everyday during the opening days of the show.
8. Both parties will not be liable for agreement's unfulfillment caused by accident (natural hazards or government regulations), but must immediately notify the other side in writing to negotiate to solve the problem.
9. After signing the agreement, Party A must settle the payment on schedule, otherwise, Party A should be liable for breaking the agreement and the Party B has the right to stop fulfilling the agreement.
10. this agreement is in duplicate, and each part keeps one.
