V. Justification of the selection of the economic operator

The Contracting Authority evaluated the bids based on the criteria specified in the Tender Documentation. The resulting order of bidders was created by ranking the bids according to the number of points obtained in the sum of all criteria from the highest to the lowest. After the exclusion of the bidder ABRASIV, akciová společnost, the Contracting Authority decided pursuant to Section 125 (1) of the Act to conclude the Contract with another bidder in accordance with the ranking that follows from the outcome of the original evaluation, i.e. with the bidder ADDITIVE MANUFACTURING TECHNOLOGIES LTD.
