Reasons for the exclusion from the Procurement Procedure:

The participant Thermal Vacuum Projects S.L.U., with its seat at C/Velluters 17 Parque Empresarial Táctica 961344831, Company ID No.: ESB75215715 was excluded from the procurement procedure on 2nd September 2022 because it did not stated the Total Bid Price in Price Bid Table. All items of this document which should be filled in by the participant stayed empty with initial value 0,00. The participant also did not send any explanation on the request of the Contracting Authority.

Since the participant's bid did not meet the award criteria when the participant did not state the Total Bid Price in CZK or EUR excluding VAT and it cannot submit filled in Price Bid Table



after the expiry of the time limit for the submission of tenders pursuant Section 46 (2) of the Act, the Contracting Authority excluded the participant from the procurement procedure for failure to meet the award criteria according to Section 48 (2) a) of the Act and for the reason the its bid has not been explained on request made pursuant to Section 46 of the Act.
